Coverage for emergency hospitalization (including undocumented persons), for those of eligible income; apply in person at 2550 Paulin Dr, Santa Rosa.

Health Insurance for Pregnant Women

Pregnancy-only coverage for mid-income pregnant women. Woman must apply before the 30th week of pregnancy. Family pays 1.5% of their adjusted gross income for services.

☺ **Pregnancy Medi-Cal** 1-877-699-6868

Pregnancy-only-related services for women, regardless of legal resident status; the application does not take into account family assets such as cars, homes and property, or bank accounts.
